Official Rules

Labor Day Grocery Grab Official Rules 2022

Description

Downtown Marceline in conjunction with Prenger Foods will offer a "Grocery Grab" Shopping Spree (hereafter referred to as "Contest"). The following prizes will be awarded: 1st prize winner will receive a free 2-minute shopping spree at Prenger Foods in Marceline. 2nd prize winner will receive a **\$100** Prenger Foods gift card. 3rd prize winner will receive a **\$50** Prenger Foods gift card.

Promotion Period

The promotion period begins Wednesday, July 27th 2022 and ends at close of each business on Friday, August 26th 2022. Tickets still be sold at the Wine & Art Stroll on Saturday, August 27th. Winner will be drawn on Saturday evening, August 27th, 2022 at 8pm at the Downtown Marceline Wine & Art Stroll.

Eligibility

Subject to the other requirements stated elsewhere in these Official Rules, entrants must be 18 years of age or older at the time they purchase a raffle ticket for this Contest. Raffle tickets will be sold for \$10 each or 3 tickets for \$20.

Members of Downtown Marceline and employees of Prenger Foods are not eligible to win this Contest.

By entering the Contest, the entrant agrees to abide by these Official Rules. Entrants agree to release, discharge and hold harmless the Downtown Marceline organization and Prenger Foods, their legal representatives, their affiliates, subsidiaries, suppliers, sponsors, agencies and their respective officers, employee, agents, board members, and volunteers *from any damages or injuries which may arise out of participation in the Contest, or out of the acceptance, use, misuse or possession of contest prizes.*

How to Enter

The Downtown Marceline organization will sell raffle tickets during the promotional period at the following locations including Prenger Foods, Magnolia Antiques, C & W Hardware, Busy Bee, and The Paper Station. The tickets will be numbered and will need the person's name and phone number **legibly** written on it. Three semi-finalists will be drawn from all tickets sold, and notified on or about August 27th, 2022. The 1st prize winner will be drawn **at the grocery grab event** on Thursday, September 1st, 2022 and will be awarded a 2-minute grocery grab shopping spree (see exclusions). The two remaining semi-finalists will receive alternate gift card prizes. Purchasers of raffle tickets need not be present at drawing time to win.

Release/Limitations of Liability

By entering the Contest, each entrant further agrees that, in the event there is any conflict or other inconsistency between the Official Contest Rules and any advertisements, promotional or marketing materials, emails or announcements relevant to this Contest, these Official Rules will govern.

1st Prize

The 1st winner will be granted a 2-minute grocery grab shopping spree of in-store shelved items for free at Prenger Foods in Marceline. The grocery grab shopping spree will take place on Thursday, September 1st, 2022 at 7pm.

Winner of the 2-minute grocery grab shopping spree agrees to the following guidelines:

1. The 1st prize winner will have 2 minutes to shop the aisles at Prenger Foods in Marceline and grab grocery items.
2. Winner will only be allowed to grab two of any like kind item. (Ex. Two cans of coffee, 2 containers of laundry soap, 2 bags of dog food etc.) If more than two are taken, those items will be excluded from the total received.
3. Winner will only be allowed to gather **\$100** in the fresh/frozen/seafood meat departments. (The two-item rule also applies to the meat department.)
4. The following items are NOT included in the spree: alcohol, tobacco, milk, medications, gift cards, lottery tickets, deli, floral, and gift department items.
5. Winner is not permitted to shop areas designated for Prenger Foods employees.
6. Winner must return to the register with their shopping cart before the time runs out. The winner will be notified over the PA system in intervals the amount of remaining time. The last 15 seconds will be counted down over the PA system
7. Weekly sale prices will be applied at checkout. Coupons are not part of the shopping spree.
8. No items from the shopping spree may be returned or exchanged. Items are not available for cash value.
9. The winner may choose an immediate family member as a substitute to take their place for the grocery grab.

Winner Notification and Redemption

Winners will be notified via phone or in person on the day of the drawing. The winners must accept the prize on the date specified within. If the 1st prize winner is not available to participate in the contest, an immediate family member may be allowed as a substitute per discretion of the Downtown Marceline organization.

Tax Information

Payment of all taxes on grocery grab items won during the grocery grab will be paid by the Downtown Marceline organization.

Publication

Acceptance of any prize constitutes permission for the Downtown Marceline organization and Prenger Foods, its affiliates, subsidiaries, advertising and promotional agencies to use winner's name, image and likenesses for advertising and promotional purposes without additional compensation unless prohibited by law. The winner further grants to the Downtown Marceline organization and Prenger Foods the right to use and publish his or her identity, image and home city and home state online and in print, or any other media, in connection with this and other promotions.
